Brill Huntley, party of the second part, all of said parties being of Anson County, North Carolina,

WITNESSETH:

That for and in consideration of the sum of Ten Dollars and other valuable considerations to them paid by the said party of the second part, the receipt and payment of which is hereby acknowledged, the said parties of the first part have bargained, sold and conveyed and by these presents do hereby grant, bargain, sell, alien, convey and confirm unto the said party of the second part, his heirs and assigns, the following described lots or parcels of real estate situate, lying and being in Wadesboro Township, Anson County, North Carolina and more particularly described as follows:

FIRST LOT: The same being Lot No. 1 in Block G according to a plat and survey made of the West Side Extension of the property of George Singleton made by A. F. Lyman, C. THIRD LOT: BEGINNING at an iron stake, Carl Patrick's line, and running in an easterly direction 219 feet to a branch then up said branch in a southwesterly direction to a point where J. Mack Coley's land comes to the branch on the west side of said branch,
