

STATE OF NORTH CAROLINA, COUNTY OF ANSON.

THIS DEED, made this 14th day of July <sup>1966</sup>, by  
Dunlap and Mills, Inc., a corporation organized and existing under and by  
virtue of the laws of North Carolina, with principal place of business lo-  
cated in Wadesboro, North Carolina  
of Anson County, State of North Carolina  
<sup>successor to Dunlap and Mills, Inc., sometimes hereinafter called the</sup>  
grantor (whether one or more), to Wadesboro Housing Authority, Inc.  
<sup>successor to Dunlap and Mills, Inc., sometimes hereinafter called the</sup>  
of Anson County, State of North Carolina  
grantor (whether one or more):

WITNESSETH, That in consideration of the sum of \$ 10.00, paid to the grantee by the grantor,  
the receipt of which is hereby acknowledged, together with other good and valuable considerations, the grantor has bargained  
and sold, and by these presents does hereby grant, bargain, sell and convey to the grantees, and his, her or their heirs and  
executrix, the following described land lying in WADESBORO Township, Anson County, and more particularly described  
as follows:

BEGINNING at a point located on the Northern margin of Sykes Avenue,  
Bennford Farms' Southwestern corner, said beginning point being located  
882 feet in a westerly direction along the Northern curb line of Sykes  
Avenue from the intersection of the Northern edge of Sykes Avenue and  
the Western edge of N. C. Highway #109 and runs thence along the Northern  
margin of said Sykes Avenue S. 88-27 W. 198 feet; thence continuing with  
the Northern margin of Sykes Avenue S. 80-04 W. 50 feet; thence continuing  
with said margin S. 66-43 W. 50 feet; thence continuing with said margin  
S. 50-00 W. 50 feet; thence continuing with said margin S. 38-26 W. 50  
feet; thence continuing with said margin S. 36-53 W. 215.50 feet; thence  
continuing with said margin S. 36-32 W. 50 feet; and S. 30-54 W. 70 feet;  
thence leaving the margin of said Sykes Avenue N. 83-57 W. 199 feet to  
a stake; thence N. 46-27 W. 210.20 feet to a stake; thence N. 32-45 E.  
477.54 feet; thence N. 82-09 E. 546.32 feet to a stake point located on  
the original line; thence S. 7-13 W. 441.26 foot to the point of beginning  
containing 9.15 acres by D. M. D. The same being carved from that certain  
tract of land conveyed by Zeta P. Mills, Widow, Fred M. Mills, Jr., et al  
to Dunlap and Mills, Inc. by deed dated January 1, 1955 and recorded in  
Deed Book 123, at page 289, office of the Register of Deeds for Anson  
County, N. C.

It is understood that the grantee is purchasing the above described  
parcel of land for the purpose of establishing a public housing project  
thereon, and that streets and roads will be established thereon in con-  
nection with said housing project. There is hereby reserved to the  
grantor, its successors and assigns, an easement across any streets and  
roads established upon said parcel of land for the purpose of ingress  
and egress to the lands adjoining the above described parcel, which stand  
in the name of the grantor.
